This guarantee shall be a continuing guarantee and shall remain in full force and effect until the Customer has paid you all moneys due in respect of the Goods or I have given written notice to terminate any future liability under this guarantee. If such notice has been given I shall be under no liability in respect of any Goods which may be delivered to the Customer after the said notice has been given.
